

# Newham Sixth Form College Structure and Prospects Appraisal (SPA): A note for Parents and Carers

## 24 May 2023

### Dear Parents/Carers,

As you will know the National Education Union members at NewVIc voted to take a 30 day strike following a dispute with the College.

At the request of NewVIc NEU, the College agreed to hold talks with ACAS to try and resolve the dispute. However NewVIc NEU have decided to continue with strike action, despite saying that the strikes could be avoided if the College agreed to meet and hold talks at ACAS.

The College's Corporation is concerned about the impact any ongoing strike action will have on its students, the College's reputation and on future enrolments. As a result, the Corporation has commissioned a Structure and Prospects Appraisal (SPA).

### What is a Structure and Prospects Appraisal?

A Structure and Prospects Appraisal is a process which enables Colleges to assess the options that will help it to continue to deliver high quality education which meets the needs of its local community.

# Why has the Corporation of Newham Sixth Form College (NewVIc) decided to commission a Structure and Prospects Appraisal (SPA)?

The College is in a good financial position, however, the Corporation is concerned about the impact that ongoing strike action will have on the life chances of its students, the College's reputation and future enrolments.

The College Corporation has a responsibility to ensure the College continues to provide a high quality education and training which meets the needs of its local community. Undertaking a SPA will enable it to safeguard the future of 16-18 inclusive learning in Newham.

## Will the Structure and Prospects Appraisal affect my child's education?

No. The process will not have any impact on your child's studies. The College will continue to operate as normal during the SPA.

## What are the next steps and how long will the process take?

There is no predetermined outcome to the SPA. Remaining standalone or undertaking a merger with another local college or college group with a local presence will be considered.

On Wednesday 27 April, the Corporation held its first formal meeting with the FE Commissioner with a further meeting on 15 May. A timetable for the SPA process has been agreed. If the Corporation does decide, in principle, to merge, the merger is unlikely to be implemented before April 2024.

Any proposals will be subject to formal consultation and due diligence before a final decision is made. Please see the timetable below:
